



## **Privacy Policy**

### **What Our Privacy Policy Covers**

This policy covers what personal information 2Pears Ltd collects, how that information is collected and why we need it. ### **What Information We Collect and How We Use It**

### **Financial information**

If you wish to pay for your delegate pass(es) by credit or debit card, we will require your credit or debit card number and expiry date in order to take the payment. Your financial information is used solely for this purpose. As part of payment processing, your financial information will be passed to a credit card processing company (currently Stripe). No record of your financial information will be held on the Site or otherwise by us following the processing of your payment. The credit card processing company does not use, share, retain or store this information for any purpose, other than to process your payment for the above purpose.
